Why does California need California Fire Safe Council?

Since its formation in 1993, CFSC has united Californians to speak with one voice about fire safety.

CFSC, a statewide non-profit organization, provides grants to local Fire Safe Councils and other community organizations using its innovative Grants Clearinghouse. Since its first year of grant making in 2004, over \$50 million in federal fire prevention funds have flowed through the Clearinghouse to groups working to keep their communities safer from wildfires.

CFSC also distributes fire prevention education materials, evaluates proposed legislation pertaining to fire safety, and empowers grassroots organizations to establish and implement fire safety programs.

CFSC provides training on a variety of topics including compliance with environmental protection laws, creation of Community Wildfire Protection Plans, board development, organizational sustainability, and develops mentoring opportunities.

What kind of projects do local groups implement?

- Community-wide or county-wide chipping programs
- Defensible space assistance for elderly, disabled or low-income residents
- Roadway brush clearance projects
- Community information surveys
- Disaster evacuation drills
- Emergency notification systems
- Street sign/house numbering visibility projects
