California Fire Safe Council (CFSC) is pleased to announce a special grant program for Riverside and San Bernardino counties. Funding available is for **fire protection planning and education projects only**.

Funding may be used to for the following types of planning projects:

- Mapping resources (GIS)
- Community or forest risk assessments and action plans
- Defensible space assessments
- Evacuation planning
- CWPP development and/or necessary updates
- Firewise communities implementation
- Home Ignition Zone (HIZ) training
- Ember Aware / Living with Wildfire literature distribution
- Radio/television education spots and/or PSAs
- Outreach and education efforts at schools and community groups
- Guides for new construction (residential and commercial) in wildfire zones
- Guides for native fire-resistant vegetation plants
- Gold Spotted Oak Borer or Bark Beetle tree mortality planning and public education

**Fuels reduction projects are not eligible under this funding opportunity.**

### Funding Available

\$411,080

### Eligible Area

Any community or organization adjacent to forested land (federal, state, local or private) within either Riverside or San Bernardino Counties is eligible to apply.

Online application will be available on August 24, 2016.

Deadline for submitting applications is 5:00pm, Friday September 16, 2016.

### Program Eligibility:

Applications must be for fire protection planning projects within the grant boundaries. Applicant organizations must have legal standing to be eligible for grant from California Fire Safe Council. Nonprofit, For-Profit or Other entities must be incorporated to do business in the State of California and have a Federal Employer Identification Number/Federal Tax Identification Number (FEIN/FTIN). An applicant organization that does not meet these requirements must identify a fiscal sponsor with legal standing to receive the funds on its behalf. Individuals are not eligible to apply.
